SPECIAL INSTRUCTIONS

1. Application form must be filled in with strict accuracy and necessary details. If any item or sub-item remains unanswered, the application is liable to be rejected.
2. Applicant should give such further information on a separate paper as may be deemed necessary by the Society.
3. If any information is false or misleading or if any material fact is suppressed, the application will be rejected and the applicant shall have to leave the institution even after admission.
4. **Application for admission should reach the Hon. Secretaries latest by the 10th of June every year for new students & by 31 st May for old students.**
5. Applicant whose result of the examination is not declared before the above dates should submit result within five days of the declaration of the result but application for admission should reach the Hon. Secretaries latest by the dates as above.
6. Fees of both the terms to be paid together within 3 days of the admission. Fees once paid, will not be refunded.
7. Students should join Vidyalaya within 3 days of Paying the fees or should apply in writing for late joining with the reason.
8. College fee Receipts and Exam worksheets must be submitted within 3 days of receipts.
9. Hostel will remain closed completely from 26th May to 5th June Every year.

1. **Sthanakvasi Jain students are eligible to apply for the admission in the institution.**
2. The student who has passed the S.S.C. or H.S.C. examination is eligible to get the admission.
3. Fees are as under, (Only Boarding Charges)

Term	Full Paying	General Deposit (Refundable)
Half Term	Rs. 25,000/-	Rs. 5,000/-
Full Term	Rs. 50,000/- + 6000 GST	for all

Fee include Hostel Fees only. Breakfast, Lunch & Dinner charges will have to be paid every month separately.

3. (a) (I) General Deposit will be refundable once student leaves the vidyalaya. If not claimed within 3 years, same will be forfeited. (II) Half free and full freeship scholarship students will have to sign an undertaking for the repayment of the loan for full freeship and half freeship per year as may be decided from time to time (III) For payment of Vidyalaya fees and general deposit, cheque should be drawn in favor of **"The Jain Education Society"**. Each student will be served two meals & morning breakfast everyday.
3. (b) Cash payment will not be accepted. Fees also can be paid through NEFT as under. The Jain education society, Bank of India Wadala (West) Branch Mumbai - 400031. S/B A/c No.005210100005579 IFSC code BKID0000052 However payment slip must be submitted to office.
3. (c) No cuts or deductions will be given for non availing meals. Separate rules are made for kitchen facility and will be given at the time of admission.
4. Old student will have to apply every year latest by 31st May to get the fresh admission. There is no automatic renewal of admission for the next year. Student whose admission is cancelled, will have to leave the Vidyalaya immediately. Student shall vacate the Vidyalaya within 3 days once the examination is over. No extension will be granted.
5. Cot, Bed and Bedsheets will be supplied. Students will have to handover full account of all the belongings supplied to him for his care to the management while leaving the Vidyalaya. If he leaves the Vidyalaya without completing the formalities, his mess deposit will be forfeited and next year admission will not be considered.
6. In the Vidyalaya, students are strictly not allowed to eat or bring objectionable articles of food (*kandmuls*) forbidden by Jain Shastras. Smoking and playing cards are strictly prohibited and will be considered a misconduct.
7. Students can play only those games in Vidyalaya Premises which are allowed.
8. No student will remain absent after 10 P.M. at night without the written permission from the Superintendent. Roll call may be taken at 10 P.M. daily. No student should leave the institution after the roll call without the express permission of the Superintendent. Any student absents himself from the institution without permission will be liable to fine. Repeated breach of this rule will be strictly dealt with including cancellation of the admission.
9. Every student will have to behave properly and should not disturb his room mates or inmates adjoining rooms by talking or reading loudly or by any other means. Birthday celebration or Loud talking or carrom game in rooms are strictly prohibited.

10. The parents, guardians, relatives and friends can meet the student in the common room only. No guest or visitor will be allowed after 9:30 P.M. guests are not allowed to stay in the hostel during the night. Lady guests strictly are not permitted in the room at any time.
11. It is the duty of all resident students to see that the walls and doors of the rooms allotted to them are not spoilt by fixing nails or by scratches or marks by pencil or such other means. Students should not fix / paste papers on window glasses and their rooms must be in a clean and orderly condition. They should not use unoccupied seats or rooms without the previous permission of the Superintendent. The Superintendent is entitled to check the room and belongings of the resident students at any time.
12. The lights in the room should be switched off when not needed and switch off before going out. Extensions from the electric lamps on plugs are not allowed. Breaching of this rule, all the room-partners will be fined by the Superintendent.
13. Staying and dining facilities are given according to the rules and regulations of the Vidyalaya. Management of the dining facility will be done according to the rules and regulations in co-operation of the students. The dining time will be decided by the Superintendent. The student who wants to keep his late dish for the lunch will have to inform in advance. Strict actions will be taken against student who keeps his late dish and does not eat. No late dish will be kept for dinner in the evening.
14. No student will quarrel or argue with the cooks or the servants of the mess. If the student has any complaint against the mess staff, should write in the mess register.
15. Student should not hand over his personal work to the servants of the Vidyalaya. Common work will be done according to the instructions of Superintendent.
16. Every student will have to attend all the examinations whenever they are held and the results of the examinations will have to be submitted to the institution within 3 days of the result.
17. No student is allowed to do any Job or private tuition-work.
18. The admission list will be displayed on the notice board and no individual will be informed. The student whose admission is granted, will have to pay his fees within three days. If he does not pay within three days, his admission will be cancelled.
19. The students who make mischief, misbehave, do not follow the rules, damage the building or the furniture of the institution, do not attend in the roll call or functions, will be fined by the Superintendent, but for any serious matter, he will be reported to the Honorary Secretary and very strict actions will be taken against him.
20. Student who wants to take leave, have to apply a day before to the Superintendent in prescribed application form. Proxy application is not allowed.
21. Every year four functions being held in the Vidyalaya and it is obligatory for all students to attend. If it is not possible due to an unavoidable circumstances, one will have to apply with the proof in advance for the permission.
22. Those who will be fined, their names will be put on the notice-board and they will have to pay the fine immediately to the office and also will be informed to their parents and guardians and they may be called if required.
